**Personal precautions, protective equipment and emergency procedures**

**Personal protection** Avoid contact with the skin and the eyes. Eye protection or face shield should be used if material is used under conditions that increase the chances of splattering. Wash skin with soap and water if contact occurs. Launder soiled clothing. If spilled, take caution, as material can cause surfaces to become very slippery.

**Other information** Small spill: Remove sources of heat or ignition, provide adequate ventilation, contain leak using absorbent, inert, non-combustible material. **Precautions for safe handling**

If contact is made, wash skin with soap and water. Launder soiled clothing. Maximum handling temperature is 70 degrees C (158 F). It is recommended to pump or transfer material at ambient temperature.

**Storage Conditions** Keep away from heat and sources of ignition. Keep containers closed when not in use. Follow first aid measures if contact occurs, and spill procedures if spill occurs. For packaged material: Store in a cool dry area. For bulk material: store in cool dry area. Always follow local, state, and federal guidelines for storage of material for amount stored.
